SUMMARY OF CLIMATE PROTECTION PRIORITIES IDENTIFIED DURING IN-PERSON CONSULTATION

- Managing climate protection actions with minimal staff and resources
- Maintenance of vehicles vs. purchasing more energy efficient vehicles
- Financing for renewable energy projects
- Continue upgrading equipment in Town facilities

CLIMATE SMART COMMUNITY SERVICE RECOMMENDATION

Expand the scope of Conservation Advisory Council to manage the Town's climate protection actions as part of their mission to protect the overall quality of the environment in Niskayuna.

CLIMATE PROTECTION ISSUE TO BE ADDRESSED

Conservation Advisory Councils (CAC) are established by the Town Board by ordinance or by local law under the statutory authority of Section 239-x of Article 12-F of the NYS General Municipal Law. CAC members are appointed by the Town Board. Their mission often includes: gathering and disseminating information, conducting research, and advising other town agencies in matters related to the conservation of natural resources. Many CACs in New York have interpreted their mission to embark on climate-related projects such as conducting greenhouse gas emissions inventories, developing Climate Action Plans, implementing renewable energy projects, and creating Climate Adaptation Plans. This has led to a more streamlined process for identifying and implementing climate protection programs in local governments due to the connection with their existing mission. By expanding the scope of the Niskayuna CAC the Town will have an existing, consolidated "home" for its climate protection efforts. Much of the start-up work associated with establishing a new committee or task force would be eliminated.
