Task 1 – Project Management and Coordination

■ ***Recent Activities:***

Final resolution of issues was conducted through a series of formal and informal communications with NYSDEC. Formal communications were developed and delivered to NYSDEC on January 18, 2007 and February 14, 2007. Formal comments were received from NYSDEC on January 23, 2007. A formal revised submittal of the Plan was made on February 19, 2007. Final resolution was formally documented in a March 12, 2007 correspondence and approval was received from NYSDEC on March 16, 2007. Approval was contingent upon certain milestones dates for more detailed submissions. The final approved Plan was distributed to the CDRPC, Consultants and Communities on April 6, 2007.

■ ***Planned Activities:***

There are no more planned activities under Part A. The consultant team, the CDRPC and the communities are currently finalizing Part B contracts. The next progress report will include the initial Part B activities.

Additional written clarifications were developed and provided to the NYSDEC in a February 14, 2007 correspondence. A formal submittal of the Scope of Work and Combined Sewer System Monitoring and Modeling Plan was made on February 19, 2007. Additional minor clarifications were requested by NYSDEC and final resolution of comments was conducted through direct communications between Leif Engstrom of the CDRPC and Greg Daviero of

the consultant team and Andrea Dzierwa of NYSDEC Region IV and Cheryle Webber of the NYSDEC's Central Office. Final resolution was formally documented in a March 12, 2007 correspondence and approval was received from NYSDEC on March 16, 2007. Approval was contingent upon certain milestones dates for more detailed submissions.

■ ***Planned Activities:***
