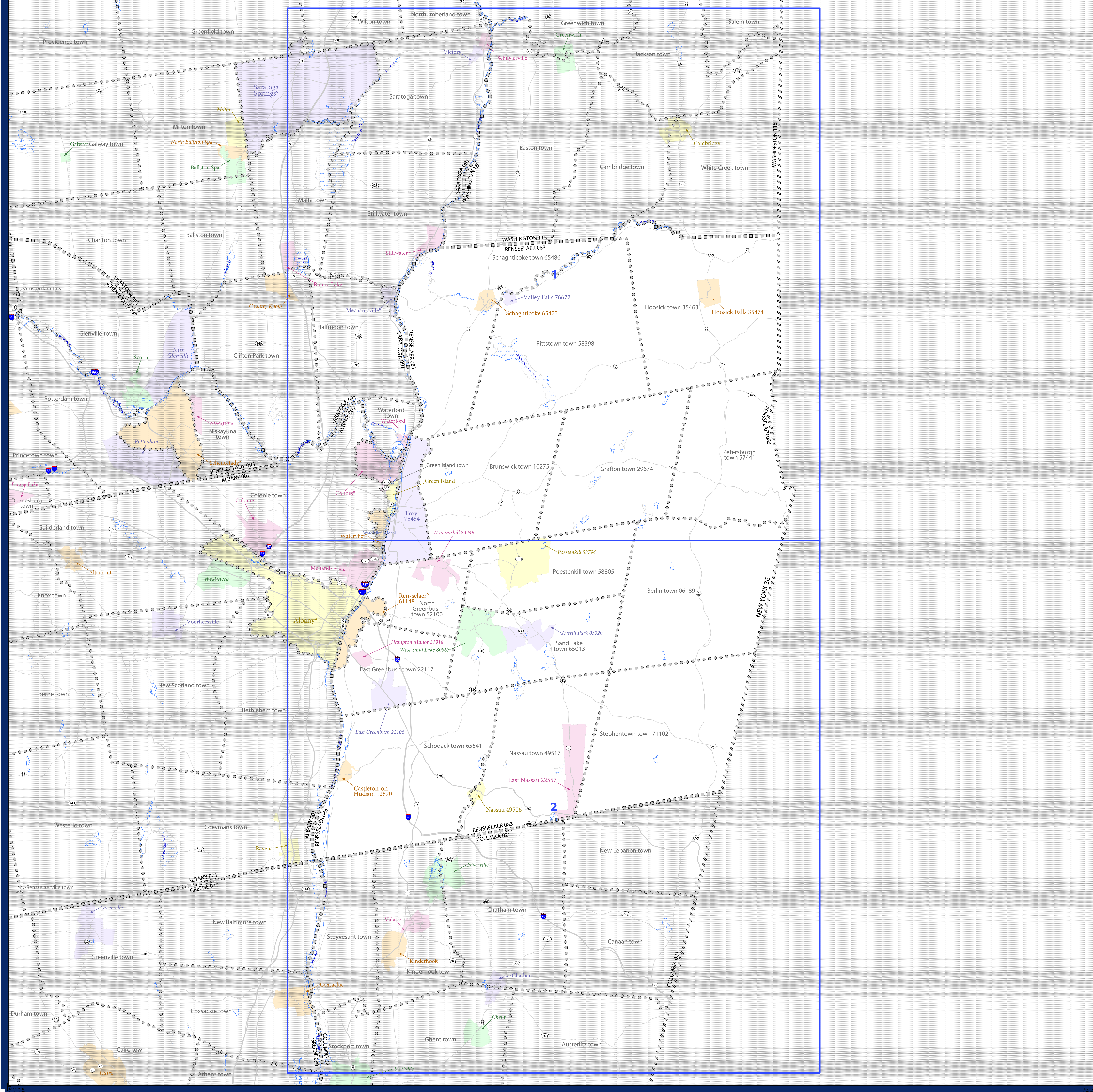


# 2010 CENSUS - CENSUS TRACT REFERENCE MAP: Rensselaer County, NY



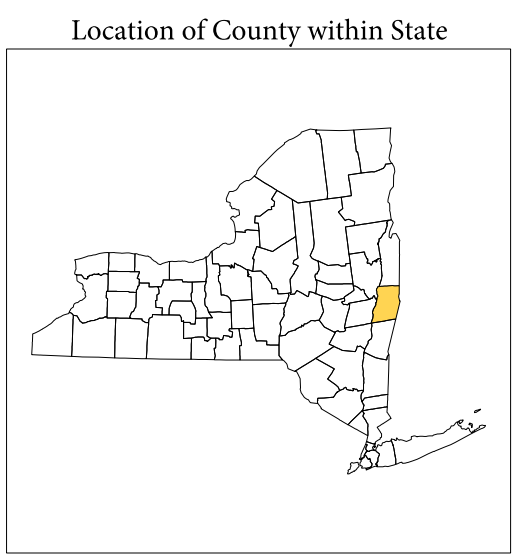

3 Place label color correlates to the place fill color.
