Educate home owners, community leaders, business owners, governments and the general public on the benefits of energy efficiency and renewable resources

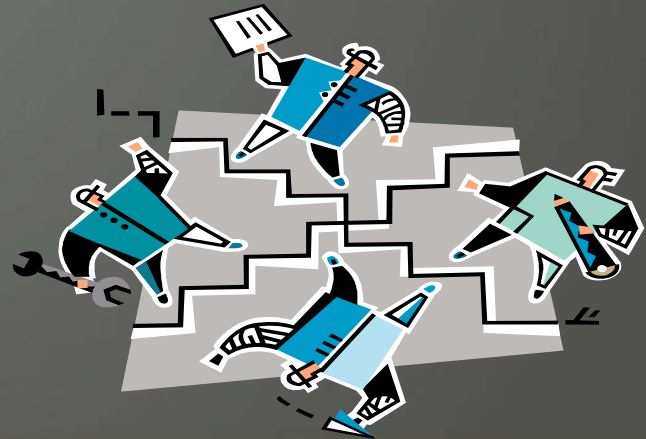

Climate Smart Communities Early Adopters

Some Local Governments adopted Climate Smart Communities Pledges early on, and completed their own formal or informal GHG/energy use Inventories

Some acted, implemented community based energy efficiency efforts and/or focused on municipal operations

Early adopters now need a formal holistic GHG inventory that will aid in a regional focus, sharing of resources and identification of focused community based efforts

These efforts may include energy efficiency, renewable energy, transportation, sustainable economic development and education

NYSERDA Programs

Energy Efficiency and Renewable Programs

Commercial Industrial –

Provides clean energy studies and efficiency services for new and existing facilities, manufacturing, and transportation

Residential –

NYSERDA's residential programs help homeowners and renters reduce their energy costs through incentives and low-interest loans

NYSERDA Programs cont'd

Economic Recovery –

Information on the full range of federal and state energy-related economic recovery programs. NYSERDA provides this information as a service to help New Yorkers take advantage of the opportunities offered by the American Recovery and Reinvestment Act (ARRA) of 2009

Multifamily Homes –

This program addresses the needs of the multifamily sector by working with developers, building owners and representatives to improve the energy efficiency, health, safety, and security of the residential buildings with five (5) or more residential units in a cost effective manner

NYSERDA Programs cont'd

Renewables –

NYSERDA invests in renewable energy through programs that provide funds to emerging businesses for product and business development, product marketing assistance, incubators for start up industry and other support

Green Jobs-Green NY –

A statewide program to promote energy efficiency and the installation of clean technologies to reduce energy costs and reduce greenhouse gas emissions. The program supports sustainable community development and create opportunities for green jobs. This program is administered by NYSERDA

NYSERDA Regional Council Program Categories

- **Sustainability**
 - **Regional Economic Development and Greenhouse Gas Reduction Program**
- **Energy Improvements**
 - **Non Residential Energy Efficiency Projects**

Regional Economic Development & Greenhouse Gas Reduction Program

- **Funding - \$12,000,000 – Max award \$1,500,000**
- **Award cost-share funding for energy efficiency, renewable energy, and/or carbon abatement projects that address the regional priorities of the Regional Economic Development Councils (REDCs)**
- **Result in strategic investments, and build the capacity within the region to participate in the State's clean energy economy.**
- **Projects must be capable of moving forward within one year, while positioning the region for long-term economic growth and environmental stewardship.**
- **The Program will complement other funding available through NYSERDA, but will not supplant funds which are otherwise available from NYSERDA programs.**
- **The focus of the Program is on the following end-use sectors:**
 - **Transportation, Manufacturing and Industrial Process, Buildings, Agriculture, Municipal process, Renewable electric generation, and District Energy**
